- o Camp fires are strictly forbidden, the organisers will impose a fine of £100 if camp fire damage is identified.
- o Dogs are welcome however they must be kept on a non-extending lead.
- All Applications should be made NO LATER than Tuesday 18<sup>th</sup> June 2024.
- o No Applications will be processed without a returned signed booking form and payment in full.
- Cancellations: In the event of an exhibitor notifying the Secretary that he/she is unable to attend before Tuesday 18<sup>th</sup> June 2024, the Society will refund the charges paid, less an administration fee of £2.50. If the cancellation is made after Tuesday 18<sup>th</sup> June 2024 there will be no refund.
- o If the show is cancelled due to poor weather (where the field is considered unusable by the organising committee) or any other reason outside the society's control, the society will refund the booking fee minus £2.50 to cover administration costs.
